

Paititi Volunteers
Release and Waiver of Liability

In consideration for being permitted to act as a Volunteer with Paititi Volunteers the Volunteer hereby waives, releases and discharges any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's activities with Paititi Volunteers. The Volunteer understands that this Release discharges Paititi Volunteers and its associates (including Paititi Peru and the principals, employees, agents and volunteers of Paititi Volunteers and Paititi Peru) with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the Volunteer's activities with Paititi Volunteers.

The Volunteer hereby releases, discharges and agrees not to sue Paititi Volunteers and its associates for any and all liability, injury and damages arising out of or connected in any way with the Volunteer's participation in the program, even though the liability, injury and damages may arise out of negligence or carelessness on the part of Paititi Volunteers or its associates.

The Volunteer understands that accidents and injuries can arise out of or in relation to this activity; knowing the risks, nevertheless, the Volunteer hereby agrees to assume those risks and to release and to hold harmless Paititi Volunteers and its associates, who (including through negligence or carelessness) might otherwise be liable to the Volunteer (or his/her dependents, heirs or assigns) for damages.

Medical Treatment: The Volunteer hereby releases and forever discharges Paititi Volunteers and its associates from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's activities with Paititi Volunteers.

Assumption of the Risk. The Volunteer understands that the program and the area in which they will be participating includes risks that may be hazardous to the Volunteer, including, but not limited to tropical and other diseases, physical injury, contact with insects and other animals, dangers related to being in the jungle, mountains and areas with undeveloped infrastructure, and transportation to and within Peru. The Volunteer hereby expressly and specifically assumes the risk of injury or harm in any and all activities and releases Paititi Peru and its associates from all liability for injury, illness, death, or property damage resulting from his or her participation in the program.

Insurance. The Volunteer understands that Paititi Volunteers and its associates do not carry or maintain health, medical, disability or other insurance for any Volunteer. All Volunteers are expected and encouraged to obtain their own health insurance and other coverage, to obtain medical advice about travel and working in Peru, and to obtain all necessary health services, including but not limited to immunizations, prior to their arrival in Peru and after.

Photographic Release. The Volunteer does hereby grant and convey unto Paititi Volunteers and its affiliate Paititi Peru all rights, title, and interest in any and all photographic images and video or audio recordings of him or her and his or her activities made by Paititi Volunteers during the Volunteer's activities with Paititi Volunteers, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

THE VOLUNTEER HAS READ THIS RELEASE AND WAIVER OF LIABILITY AGREEMENT, FULLY UNDERSTANDS ITS TERMS, UNDERSTANDS THAT HE
